Tax Grievance Deadlines...Is Yours Coming Soon?

A property's real estate taxes are based on the property's assessment. The property's assessment is set by the assessor in the local municipality where the property is located and is supposed to be based on the property's fair market value. The taxes a property owner pays are calculated based on the property's assessment.

Sometimes properties are fairly assessed, but sometimes properties are over-assessed in which case property owners are paying more than their equitable share of real estate taxes.

With the help of James G. Dibbini & Associates, P.C., it is possible to protest your property's assessment and potentially get your taxes reduced if your property is over-assessed. The first step in this process entails reviewing the facts of a case, and if there appears to be a meritorious case, the next step is filing a complaint (also known as a grievance) with your local municipality within a specified time called the grievance period. It is important to submit the complaint with some evidence of the property's value, such as a market analysis of comparable sales or an appraisal report.

Every municipality sets its own grievance period. The grievance period is the only time to contest the assessment. The grievance periods are as follows: (Please note: the deadlines may change each year, and each deadline is estimated and should be confirmed by your local assessor's office):

November 1 – November 15, 2010
